## Who We Help

the Massachusetts Adult Foster Care (AFC) Program is intended to provide clinical and financial aid to qualified family members or caregivers who are providing long term ongoing care to an adult who cannot safely live alone.

This can include individuals with cognitive or developmental disabilities, acquired brain injuries or other limiting physical conditions, and especially seniors who require daily live-in assistance due to the natural process of aging

Through the State Entitlement Program, qualifying caregivers who live with and tend to qualifying recipients are given monthly funds to help cover the tasks associated with routine daily care, as well as clinical support and direction from our dedicated team of nursing professionals.



## How Can We Help?

The Massachusetts AFC program provides direct financial aid and clinical support to caregivers already offering routine assistance with an individual's "Activities of Daily Living" (ADL's). Through our inclusive AFC program, applicants will be matched with a nursing professional who will work with them to develop a detailed plan of care, help to identify any potential risks in the home, and monitor ongoing care to help provide the best quality of life for both the live-in caregiver and recipient. Some ADLs that qualify for assistance and compensation are:

- 24-Hour Supervision
- Caregiver Training – initial and continuing
- Care Management
- Companionship
- Bathing – includes grooming and personal hygiene
- Dressing / Undressing
- Housekeeping
- Laundry
- Meal Preparation / Clean Up / Eating
- Maintenance of Wheelchairs and Adaptive Equipment
- Medication Management – includes assistance with paperwork to receive prescribed medications
- Mobility
- Shopping for Essentials
- Toileting
- Transferring
- Transportation – to appointments



## Who Is Eligible

Eligibility for the Massachusetts AFC program is dependent on several location and income based factors with the most basic qualification being that the care recipient is at least 16 years of age and cannot live alone due to the medical necessities of their condition. The caregiver must be at least 18 years of age and both individuals must live in the same private home.

The Massachusetts AFC program is an entitlement which means that as long as the applicant meets the standards for Medicaid eligibility, they cannot be denied funds or service for any other reason and are guaranteed the full benefit of this helpful program.
